3. **Manner of Depositing Bids.** Sealed Bids should be either dropped in the Tender Box marked as Army Public School Dighi or sent by registered post at the address given above so as to reach by the due date and time. Late tenders will not be considered. No responsibility will be taken for postal delay or non delivery/non-receipt of Bid documents. Bids sent by e-mail will not be considered (unless they have been specifically called for by these modes due to urgency). Technical & Commercial Bids kept in separate envelopes, otherwise Bid may be rejected.

4. **Location of the Tender Box:** Only those Bids that are found in the tender box at Army Public School Dighi will be opened. Bids dropped in the wrong Tender Box will be rendered invalid.

5. **Place of opening of the Bids:** The Bids will be open by the BOO at Army Public School Dighi. The Bidders may depute their representatives duly authorized in writing to attend the opening of Bids on the due date and time. Rates and important commercial/technical clauses quoted by all Bidders will be read out in the presence of the representatives of all the Bidders. This event will not be postponed due to absent of your representative.

6 **Forwarding of Bids:** Bids should be forwarded by Bidders under their original memo / letter pad inter alia furnishing details like GST number, Contact Number, complete postal & e-mail address of their office.

(a) **1ST Envelope contains the Tech Bid - Firm Registration/Shop Act, GST Registration, PAN Card, NEFT Details.**

(b) **2ND Envelope contain the Financial Bid - Rates will be quoted as per given accounting sheet.**

7. **Validity of Bids:** The Bids should remain valid for a period of 120 days from the last date of submission of the Bids.

PART- II ESSENTIAL DETAILS OF INSTALLATION OF INTERACTIVE PANEL BOARDS (SMART BOARD) WITH REQUIRED ACCESSORIES FOR CLASSROOMS

1. **Technical Literature:** The Bidders must enclose technical literature of the equipment indicated in the Bill of Materials for each item in proper order, duly mentioning the **Make and Model** in Technical Companies Statement. Tenders received without required information will be rejected.
2. **Delivery Period:** Within 30 days of placement of work order/signing of contract as applicable. Contract can be cancelled unilaterally by the Buyer in case items are not received within the contracted delivery period. Extension of contracted delivery periods will be at the sole discretion of the Army Public School Dighi with applicability of LD clause.
3. **Scope of work:** The project involves the supply and installation, commissioning and testing of the **PURCHASE AND INSTALLATION OF INTERACTIVE PANEL BOARDS (SMART BOARD) WITH REQUIRED ACCESSORIES** at Army Public School Dighi. The Army Public School Dighi reserves the right to amend/add/delete/edit any of the items of the scope of work, which shall be binding on the successful Bidder.
4. **Training:** The vendor is required to provide free of cost training to minimum **03** persons for a duration of **03** days at Army Public School Dighi, post commissioning of project on the following:
 - a) Preventive maintenance of the item and associated software supplied.
 - b) Basic Operation and Daily Inspection.
 - c) Installation, Maintenance and Trouble shooting.
 - d) Software, Application use.
5. All prices will be landed costs, inclusive of all taxes, freights etc.
6. **Delays in the Suppliers Performance:** Delivery of the goods and performance of the services shall be made by the supplier in accordance with the time schedule specified by the purchaser in its purchase order. In case the supply is not completed in the stipulated delivery period, as indicated in the Purchase order reserves the right either to short close/or cancel this purchase order and /or recover liquidated damage charges. The cancellation or short closing of the order shall be at the risk and responsibility of the supplier and purchaser reserves the right to purchase balance unsupplied item at the risk and cost of the defaulting vendors.
7. Delay by the supplier in the performance of its delivery/services obligations, shall render the supplier liable to any or all of the following actions:
 - a) Forfeiture of the performance security,
 - b) Imposition of liquidated damages and or
 - c) Termination of the contract for default.

PART – III STANDARD CONDITIONS OF RFP

The Bidder is required to give confirmation of their acceptance of the standard conditions of the RFP mentioned below which will automatically be considered as part of the contract concluded with the successful bidder (i.e. Seller in the contract) as selected by the buyer failure to do so may result in rejection of the bid submitted by the bidder. Format of Certificate- Acceptance of Term and Conditions of the RFP is enclosed as **Appendix 'A'**.

1. **Liquidated Damages:** In the event of the seller's failure to submit the bonds, guarantees and documents supply the stores/goods and conduct trials, installation of equipment, training etc as specified in this contract. The buyer may at his discretion with hold any payment until the completion of the contract, The buyer may also deduct from the Seller as agreed , liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.
2. **Termination of Contract:** The buyer shall have the right to terminate this contract in part or in full in any of the following cases:
 - a) The delivery of the material is delayed for causes not attributable to Force Majeure for more than **2 months** after the scheduled date of delivery.
 - b) The seller is declared bank or become insolvent.
 - c) The delivery of material is delayed due to cause of Force Majeure by more than **3 months** provided Force Majeure clause is included in contract.
 - d) The buyer has noticed that the seller has utilised the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.
 - e) As per decision of the Arbitration tribunal.
3. **Amendments:** No provision of present contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this contract and signed on behalf of both the parties and which expressly states to amend the present contract.
4. **GST:** As applicable, Bidder must indicate the relevant GST likely to be paid in connection with delivery of complete goods and services specified in RFP.

PART – IV SPECIAL CONDITIONS OF RFP

The bidder is required to give confirmation of their acceptance of special condition of the RFP mentioned below which will automatically be considered as part of the contract concluded with the successful bidder (i.e. seller in the contract) as selected by the buyer. Failure to do so may result in rejection of bid submitted by the bidder.

1. **Option Clause**: The contract will have an Option Clause, wherein the Buyer can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same terms & conditions of the present contract. This will be applicable within the currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. It will be entirely the discretion of the Buyer to exercise this option or not.
2. **Repeat Order Clause** – The contract will have a Repeat Order Clause, wherein the Buyer can order upto 50% quantity of the items under the present contract within six months from the date of supply/successful completion of this contract, the cost, terms & conditions remaining the same. The Bidder is to confirm acceptance of this clause. It will be entirely the discretion of the Buyer to place the Repeat order or not.
3. **Payment Terms for Indigenous Sellers** - It will be mandatory for the Bidders to indicate their bank account numbers and other relevant e- payment details so that payments could be made through ECS/EFT mechanism instead of payment through cheques, wherever feasible. A copy of the model mandate form prescribed by RBI to be submitted by Bidders for receiving payments through ECS is at Form DPM-11 (Available in MoD website and can be given on request). The payment will be made as per the following terms, on production of the requisite documents.
4. 100% payments will be processed on acceptance / satisfaction of Installation of Interactive Panel & inspections of the Installation of Interactive Panel.
5. **Advance Payments.**: No advance payment(s) will be made, 100% after completion of project in all respects.
6. **Inspection Authority**: Local Board of Officer.
